Subscribing to Fireworks (magazine)

Your annual subscription must be paid in advance, using the payment facilities available on this Website, and Fireworks (magazine) will thereafter supply you with two issues (annual subscription) or individual copies of back issues, or single or multiple copies of one, or more, of any issues as ordered. If at any time you are dissatisfied by the service or products supplied by Fireworks (magazine) you are entitled to cancel your subscription and receive a full refund for the periodicals you will not receive that year.
